Membership to Vote on Proposed Constitution Changes

The Board of Officers has recently discussed changing our club name to clearly distinguish ourselves from the Wirehaired Pointing Griffon breed, to move away from a long and rather convoluted name, as well as well to more accurately represent our breed. The Board is proposing to change our club name to "Český Fousek North America" and to make the necessary changes to the club Constitution. Changes to our Constitution require approval by 2/3 of votes cast by paid-up members.

Since our last name change (in 2015, to "Bohemian Wirehaired Pointing Griffon Club of America"), we have imported over 60 Český Fousek puppies from the Czech Republic and The Netherlands. Many attempts have been made to register our dogs as Český Fousek with recognized breed clubs. After years of help from the Czech club we have gotten official word from the Fédération Cynologique International (FCI) that our dogs should be registered through the Fédération Cynologique Puerto Rico (FCPR). [Puerto Rico is a territory of the United States]. We have several dogs that will be registered through the FCPR and plan to continue that process. By registering our dogs through the FCI, the parent organization to the FCPR, and more closely aligning our club with the Český Fousek clubs worldwide, we can gain more widespread and formal recognition of our dogs. It has been suggested that changing our club name to be representative of the Český Fousek would be logical step to take prior to signing any formal agreement with the FCPR. In addition, the Club has already registered "Český Fousek North America" as an online domain name.

The proposed Constitution revision, as recommended by the Board of Directors, would replace the words "Bohemian Wirehaired Pointing Griffon Club of America" with "Český Fousek North America". In addition, Section 6 of the Constitution would be changed from the Griffon Registry Book (GRB) to the Český Fousek Registry Book (CFRB). The proposed revised Constitution can be viewed online at:

All votes on the proposed change must be cast within 30 days of the mailing date on this August 2019 issue of Gun Dog Supreme. Note: Only paid-up members can vote. Ballots will be mailed to coincide with delivery of the GDS to all club members who have paid dues in 2018 and 2019. The mailing will include a ballot and a membership form. If you have not yet paid your 2019 membership dues, but wish to vote, you may still do so by paying your dues online at:

Editor's Note:

The changes proposed to the constitution are identified below. Terms to be replaced are printed in strikethrough font. New terms are printed in **Bold** type.

There are three related changes in the proposal. Members are asked to approve each.

- 1. The name of the club shall be changed to: "Český Fousek North America."
- The breed name used throughout the constitution shall be changed to "Český Fousek."
- 3. The club breed registry book shall be changed to:" Český Fousek Registry Book (CFRB)."

Constitution Bohemian Wirehaired Pointing Griffon Club of America

Český Fousek North America

(Revised 2015 2019)

Article I. Name and Purpose

- Section 1. The name of this organization is the Bohemian Wirehaired Pointing Griffon Club of America Český Fousek North America.
- **Section 2.** The purpose of the club is to protect, promote, and improve the Bohemian Wirehaired Pointing Griffon Český Fousek breed by such activities as:
 - Developing recommended breeding programs based on performance and type, as outlined in the breed standards.
 - Sponsoring and participating in field tests that are designed to evaluate the versatile hunting qualities of the Bohemian Wirehaired Pointing Griffon Český Fousek.
 - Sponsoring local chapters of the Bohemian Wirehaired Pointing Griffon Club of America Český Fousek

North America.

- Affiliating with foreign clubs and studbooks devoted to the advancement and protection of hunting dogs
- Cooperating with all other clubs and organizations devoted to the advancement and protection of hunting dogs: and
- Acquainting hunters with the characteristics of the Bohemian Wirehaired Pointing Griffon Český Fousek.

Section 3. The club is a non-profit organization.

Article II. Activation and Membership

- **Section 1.** The club was activated in 1951 and has been active since that date.
- **Section 2.** Persons of good standing interested in the Bohemian Wirehaired Pointing Griffon Český Fousek and approved by the Board of Directors become members upon payment of annual dues. Active members are those who have paid their annual dues for the current year.
- **Section 3.** The Board of Directors at the discretion of the Board of Directors may make expulsion of a member by a majority vote, for any action that they believe to be detrimental to the club. Expulsion shall not be contestable, except that the expelled member may apply for membership in any succeeding year.
- **Section 4.** The club may elect to lifetime honorary membership, without payment of dues, any person who makes an outstanding contribution to the purpose of the club.

Article III. Officers and Committees

Section 1. The officers of the club are the President, Vice-President, Secretary, and Treasurer. Officers serve for three years and without pay.

- **Section 2.** The President appoints acting officers to fill vacancies occurring between elections and appoints regional chairs and committee chairs as may be required. The President, in consultation with the other officers, appoints a member of the Cclub to serve as Editor of the Cclub news bulletin, and a member to serve as Registrar.
- **Section 3.** The Secretary is the executive agent of the Cclub. He or she maintains records of the Cclub, conducts Cclub correspondence, and conducts the business of the Cclub in accordance with its constitution and motions adopted by the Cclub.
- Section 4. The Treasurer receives all Cclub membership fees and other monies for the Cclub, except monies directed elsewhere by the President. He or she maintains the Cclub bank account as directed by the President. He or she maintains a record of all Cclub monies. Once per year, he or she prepares the annual Treasurer's Report for publication in the December issue of the Cclub news bulletin, The Gun Dog Supreme. This annual financial report must be submitted to the Board of Directors (via the Secretary) prior to publication in the Cclub news bulletin. The Treasurer also processes all new member applications, which are then forwarded to the Secretary.
- **Section 5.** The Editor of the Cclub news bulletin, The Gun Dog Supreme, publishes the news bulletin six times per year under the direction of the Board of Directors. He or she ensures that the news bulletin is available to each paid -up Cclub member.
- Section 6. The registrar maintains the Griffon-Český Fousek Club Registry, called the Griffon Český Fousek Registry Book (GCFRB), and related items, such as certified pedigrees, litter and individual registrations, Breeders Agreements, and reports directly to the Secretary. He or she also presents an annual report of the Registry to the Board of Directors.

Article IV. Elections

Section 1. Any paid-up members mail nominations for officers to the Secretary prior to November 1 of an election year. The Secretary will publish in the December, The Gun Dog Supreme of an election year, all nominations received. All votes mailed to the designated vote counter, prior to December 31 of that year, after publication of the slate of nominees, are counted, and elections is by majority.

Article V. Parliamentary Procedure

- **Section 1.** The parliamentary business of the Cclub is conducted by mail or email. To the extent practical, Robert's Rule of Order applies.
- Section 2. Normal procedure requires the Secretary, by correspondence and through the medium of The Gun Dog Supreme, to canvas the opinions of the Colub members and to frame appropriate motions to be presented to Colub members either by mail, email, or by publication in The Gun Dog Supreme. A simple majority of votes cast by paid -up members within thirty days carries a motion, except for motion to revise or amend the constitution, which motions require a two-thirds majority.

Article VI. Dues

Section 1. The annual dues are sixty dollars (\$60) unless changed by a vote of the membership by a simple majority, payable on January 1 of each year.

Success! Formal Recognition of our Club Dogs by Laurie Connell

For many years our club has been trying to have some sort of official recognition in the broader dog world. Our dogs have been called illegitimate and worse on some websites and within the Wirehaired Pointing Griffon world there continues to be the impression that we do not have legitimate dogs, websites warn against acquiring one of our dogs. Now we have the opportunity to change the club name to one that does not include the word "griffon" and that will help us get away from that stigma. But there is another set of steps that will also help. These are 1) having our dogs officially recognized in a major dog organization and 2) have our club become the breed club in that organization so that we can set the rules for breeding dogs. The Fédération Cynologique Internationale (FCI) is the largest international canine registration organization and their registrations are accepted by all other major dog organizations that recognize the Český Fousek breed.

The general club member may have little interest in this endeavor because they just want a good hunting dog. But part of that effort requires a robust breeding program. That is the part of the puzzle that is greatly helped by official recognition in a worldwide organization. In addition, some members of our club would like to participate other dog-world events, such as NAVHDA or UKC events as well as in Český Fousek events that require registration in the FCI, for example the Český Fousek World Cup. Further, this will allow us to export dogs for other countries breeding programs to help maintain genetic diversity.

As many of you may remember, I have been working for the last six years trying to find a path to have our dogs recognized without moving into the American Kennel Club (AKC) or Canadian Kennel Club (CKC) world. It is important to maintain control of the breed as hunting dogs. This philosophy is held by our Parent Club, the Klub Chovatelů Českých Fousků (KCHČF), and is held under their rules in the FCI.

The Český Fousek is not currently a recognized breed by the AKC or CKC. We firmly believe in the work of the KCHČF has accomplished with their national hunting breed, a rare breed, with breed management. The KCHČF has established breed lines as well as the requirement for exterior, working ability, and health. Our club also have these basic requirements for breeding animals. Many rare breeds that have been registered with the AKC become popular and the breeding of those races became uncontrolled resulting in deterioration of the breed. We understand that rare races require breed management. In addition, the AKC does not allow any outcrosses with similar breeds for genetic diversity to maintain good health, as the FCI does, and the KCHČF has done. Therefore, our club did not request recognition though the AKC. In 2014 we attempted to have our club dogs recognized by NAVHDA however, because of our long tumultuous history with NAVHDA we were turned down. Dead-end.... We also approached the United Kennel Club (UKC) but we could not have our domestically bred club dogs accepted for breeding registration. Another dead-end.....

The process working with the FCI took nearly three years, hit many dead-ends, and came up against much misinformation. However, Pavel Dostál and I persisted. While some of us were in the Czech Republic for the World Cup in the fall of 2018 our club President, Jim Crouse, and I met with MVDr. Široký, president of ČMKU (Czech kennel club, member of FCI) and Pavel Dostál, as representative of the KCHČF, to find out what path forward our club might take so that our dogs could be recognized by the FCI. Pavel Dostál spoke with MVDr. Široký in early November 2018 and reported that MVDr. Široký meet in Poland with the president of the FCI, Rafael de Santiago from Puerto Rico, and with Yves De Clercq FCI Executive Director from Belgium. The suggestion then was that the ČMKU be the organization that would register our dogs. That lead to many letters back and forth as well as getting a letter from the AKC as to why we would not be registering our dogs in their organization. This turned out to be another one of those dead-ends.....

SUCCESS AT LAST! In May 2019 the FCI held another international meeting at the Shanghai China International Dog Show where our question of registration was again brought up. Last month we finally got word from the FCI (Yves De Clercq) that we should register our dogs through the Puerto Rico FCI kennel club, Federación Canófila de Puerto Rico (FCPR) because they are part of the US as a territory.

The process for registering domestically bred dogs and those with FCI Export Pedigrees are different. Registering litters is straightforward but requires both parents to be registered in the FCPR.

Dogs that possess an FCI Export Pedigree (from Czech Republic or The Netherlands) have a straightforward process and the owner need only send the original FCI registration, an FCPR form, and the fee to the FCPR headquarters in San Juan. These are through regular US mail and no additional postage is needed. There remained the question on how the FCPR would handle approving registrations of our club dogs that do not have an FCI Export Pedigree. In the Czech Republic two FCI approved breed judges need to inspect the dog and certify that it conforms to the breed standard before a registration can be complete. This would mean we would need two FCI judges come to the US and inspect all of our breeding dogs. However, the FCPR only requested a series of photographs instead of in person evaluation by judges. As a test of the process, I sent in a registration request for Allagash of Coyote Hills and had no problem with getting a permanent registration certificate in the mail.

The club registrar (Laurie Connell) can help anyone who wants an FCI registration with this process. Allow one to two months for the final paperwork to be returned to you.

Our club goal is to have all of our litters registered in FCPR and then if owners wish to obtain a full registration to enter an FCI, NAVHDA, or UKC event they will have that opportunity open to them.

Getting the word out to the greater hunting dog world can benefit our club and the breed in North America. This endeavor may take some additional time but can lead to fun opportunities for ourselves and our dogs.

Northeast Spring Test 2019

During a bit of an overcast and cool day in May we met in Winterport Maine to test four of our young dogs. Rick Molt was the senior judge with Phil Bennett and Dennis Carlson filling out the judging ranks. Laurie Connell and Andy Ogden apprenticed and Kurt Soneson and Mark Canfield were our able bird wranglers. Dennis flew into Bangor the night before the test from Hood River, Oregon. Participants and spectators arrived from all over New England as well as Pennsylvania. We were pleased to have several potential new members come and watch. The Kenneleys arrived from Boston MA with their 7 month old non-club imported female, **Moly od Vavřineckého**

rybníka, and a beautiful Český Fousek cake for the club dinner.

The test had three natural ability tests and one intermediate hunting dog test. We began the day with the traditional hunting horn music as well as a Czech "welcome to the hunt" song.

The first and second up were the last two of the "D" of Valley House pups (Flik z Lovčických tarasů x Brita Eso) to be tested this year. We began with Dasch and Paul

Fazio from PA. Dasch opened up with a nice search of field and closed in when entering heavy cover in the woods. Despite some distractions in the gallery he did finally come around and gave a solid point. The bird did not cooperate for his first track so a second track was set up and he tracked very well didn't give up after the bird went into a rock wall. Dasch had no problem in the water and ended with a prize I, perfect score.

Second dog of the day was **Doc Holliday of Valley House**, also known as Bohdi, handled by Chance Carlson. As with his brother, Bohdi showed plenty of game drive and lots of exuberance in the water. Bohdi had a very nice search and track with a delivery to hand. We saw a very solid point and good work between the handler and dog. Another nice prize I, 28 points was racked up by the Valley House pups.

Bella z České Jahodnice (Erik z Lívy x Jenny ze Sokolí doliny) with David Trudell from PA was the last NAT of the day. Bella is a very nice imported brown female that had little exposure before the test. We could see the "wheels turning" and her learn all through the test. Her search improved by the minute as she gained confidence. Bella exhibited a good nose but didn't point so unfortunately there was no prize. However she did return both birds directly to hand! When Dave gets more exposure and experi-

ence for her and works in the water she will be a fine hunting dog. We look forward to a much-improved performance for the IHDT.

Last up for the day was our IHDT with Alby of Bald Eagle (Alan od Tí stromů x Cira od Aliny z Nehvizd) and Bryan Pennington all the way from NC. Alby is a handsome 24 mo. male. Alby started his search tentatively and had some difficulty getting out effectively but when he entered the woods his search improved markedly. It should be noted that the test site is also where Alby lived all last summer so he knew there wouldn't be birds in the field. This was followed with a staunch and productive point. His Retrieve of Dragged Game was going well and he crossed the stonewall easily but on the way back he dropped the bird 30 yards from Bryan and then brought the bird to hand with an additional command. There is only one word for a track of Pheasant where an efficient and steady track is followed by a classic retrieve to hand - Perfect! On track of the duck Alby tracked to the waters edge but had difficulty crossing the body of water. As often happens the stronger the urging and the more rocks thrown the more confused and tentative he became. At this point Alby refused to retrieve a duck from deep water and no score could be given. Most dogs and handlers would have given up and headed to the truck but not Alby and Brian. They took a little walk regrouped and were able to get a score of 2 on the blind retrieve. The bond between this handler and dog are exceptional. The improvement in this dog from his NAT in Idaho to his IHDT is nothing short of amazing. We are certain that when Alby comes back to test again he will come away with a prize I, he certainly has the ability.

In the evening we voted in a new treasurer, Anita Trial (new owner of Austin of Shaw Brook) and Andy Ogden gave a report from the National meeting. Many thanks to all those who attended and helped make the Northeast spring test a success.

RMGC Spring Test 2019 by Tawna Skinner

Twenty dogs were evaluated at the Rocky Mountain chapter of BWPGCA annual spring test this year. The weather was pleasant, except for Friday when 40F. temps and a cold 20+ mph wind created frigid and challenging scenting conditions.

Over the 3 days, 13 pups from the club's 2018 breedings were tested. 6 pups prized. Tracking the live pheasant seemed to be the major challenge for these young dogs, though some also had difficulties with pointing and water. With a late winter across the West this year, access to open water for swimming practice was minimal and some of the pups had not had enough bird and handling exposure in their young lives to be able to exhibit the qualities/skills we are evaluating in NA test.

Five Intermediate, one Older Hunting dog and one UFT dog were also tested. None of these dogs were able to prize; however, all the dogs showed great game desire and searching abilities. All of the older dogs had difficulties with "track of the duck" including the UFT dog **Salmon River Dynamite**, who, without getting a toe wet or tracking scent on water, found the duck and brought it to hand. **Dora Eso**, owned by Ron Lilejdahl, demonstrated her perseverance and tenacity in the duck track when she tracked the wayward duck that had left the pond area, crossed a field, a ditch and was

headed to parts unknown through the sagebrush. She found and caught the duck and ate part of the leg. This eating of game has been a problem for the pair and eliminated the prize for her qualifying score. However, this little brown dog demonstrated that she has "all the goods" to be a great hunting companion when they get the "game mutilation" under control.

Prior to the three days of testing, the RM chapter offered a Pre-test practice/training day. All of the older dogs/handlers attended and 5 or 6 of the pups. The day was sunny, yet cool, just right for practicing skills. In the morning, at the test site we worked with the pups. Tawna Skinner helped handlers/dogs with a tracking exercise. Gary Pool helped handlers/dogs at the pond. It was suggested that all the pups go for walks over the testing site to introduce them to the new terrain, smells, cover, water, etc.

In the afternoon, all of the older dogs practiced their skills in blind retrieve, track of the duck, live bird tracking and searching. According to handler's comments, pre-test training day was very helpful, and some said their dog would not have done as well as they did without that day's practice.

Our Saturday evening banquet was held at a new venue, just ten minutes from the motel. It was catered by Elevation 486, a local and quite popular Twin Falls restaurant. The meal of BBQ pork ribs, salad, potatoes, vegetable and dessert was outstanding and the service excellent. As a result, it will most likely be the venue for next year's Judge's Seminar. Over 50 members attended and through their generous support of our raffle and silent auction fundraisers, we were able to generate sufficient funds to cover our yearly test expenses and make a bit of a profit.

Lunches at the test site were again wonderful, thanks to our chapter president, Angie McDunn and all the members who donated their special foods to the cause.

With four days of activities this year at out test site, it takes a lot of planning and logistics to make it all run smoothly and successfully. Once again, the club members willingly and happily stepped up to accomplish all the myriad tasks necessary. Thank you all so much, we could not do it all without you.

A little more than a week before the Heartland Spring Test, Dave Reed the unflappable Test Chairman, sent this email to Senior Judge Jim Crouse (check the time). So goes the run up to every test. Put out the fires, keep moving forward. Thanks Dave!

The weekend started Thursday when five handlers and their dogs took advantage of the Training day put on by Heartland Chapter Judges. This training day is an opportunity for handlers to have access to live birds for a pheasant track or for Intermediate Hunting

Dogs, to use a live duck for a track or use dead birds for a last-minute drag track or a blind retrieve in simulated test conditions. We encourage all handlers to take advantage of this wonderful opportunity in the relaxed atmosphere before the test.

Friday the Sauk Prairie Grill hosted the annual Board of Directors meeting with the Judges Seminar following. One subject of the seminar was: Judges, recruitment and retainment. The discussion touched on the best methods to introduce new apprentices to the art of judging. Judging is a hard job but so important for the Breeding Committee to acquire accurate information on the dogs produced by the club's breeding program and all interested members are urged to get involved. It requires a sacrifice of time and effort but will make you a better dog trainer/ hunter and allow the club to make informed decisions to keep improving the conformation and ability of our dogs. During the training of judges, it has been a common practice after watching a dog perform a task to gather the judging group and discuss what was observed and determine a score. Since the score represents what was observed, like the math I was taught in my dim distant youth, the answer is only as important as the process to determine the score. Apprentice Judges are normally asked to give their observations first to show their thought process, before a score is determined. During my own stint as an apprentice judge, I spewed words at random, hoping to hit the magic sentence to describe what I saw the dog do, finally sputtering to silence under the steady interest of Senior Judge John Pitlo. After a few years I did observe that a correct description of the dog's performance would occasionally earn the apprentice a small nod from the Senior Judge, positive enforcement at its finest. After witnessing the sardonic humor of President Jim Crouse for years, several of us saw the jaw dropping sight of Jim giving apprentice judge Dave Read a hug. I got a picture. The BWPGCA President is putting words into action!

During the training day on Thursday, Ajax aus Böhmerwald was retested in pointing and water work. A Prize 1 was earned by Alibi of Buckeye Valley and owner Ken Erb. There was impressive work by all the dogs but the hang up was in the two categories that lie out of the Natural Ability portion of the test, the drag track and the water work. Therefore, long before I finished the Natural Ability test with Adler of the High Country in 1995, the idea of retrieve training is repeated and repeated for those that have completed the Natural Ability Test and are preparing for the Intermediate Hunting Dog Test. In addition to perfecting the retrieve, the drag track, the duck track and the blind

retrieve usually need to be practiced a few times by the dog and handler before the test in order for the dog to pass and even then if there is going to be a bump in the road during the test it will be in these categories. For dog and handler, it is always more comforting to have gone through all aspects of the test while training so both you and the dog are confident with doing the tasks. Then even if the team has trouble with one of the categories on test day, the team will be able to get back on track and continue for a good performance.

The Natural Ability dogs being tested were Hemingway of Auger Falls, Darwin Wallace of Valley House, Hunters Destiny of Auger Falls, Henry of Auger Falls, Hadley of Auger Falls, Choot of Nichol's Creek, Callie of Nichol's Creek and Cider of Nichol's Creek. All the dogs showed great natural ability with most receiving a prize. The handlers did a wonderful job of exposing these dogs to the places of such great fun, the field and ponds.

We gathered Saturday night at the Sauk-Prairie Grill for a fabulous dinner and reading of the test scores. It was a grand evening of great food, conversation and prizes. We are so lucky for all the people that bring items to auction or give away. Instilling Good Habits for Tracking Live Birds by Rick Sojda

A few of us were visiting after the recent Rocky Mountain Exposure Day about how often we see young dogs at their NAT and IHDT have difficulty focusing on tracking birds. This came to mind for us after we watched in awe at how well the almost four-month-old Bru of Bald Eagle did on tracking her very first chukar. The Club uses Training and Exposure Days to assist with this, and maybe some other simple exercises at home might help. Nearly all dogs are born with incredibly sensitive noses. Some seem to inherently know how to use theirs and focus on scent. Some need more guidance than others. A bit of nurturing never seems to hurt. Somewhere along the proverbial path of life ...I think about 1975... I was taught a simple way to encourage a puppy to focus on ground scent. I think that I have done it with all five of my dogs over the years, but my memory fades on the details. The exercise is a precursor to tracking the live bird, the duck on the water, and completing the drag efficiently when it is older. I am using the words "track" and "drag" interchangeably, here, but that distinction will occur later in the dog's life.

The exercise I have used is simple, and some others at our Exposure Day had not heard of it. All you need to do is drag a wing or a small dummy with wings taped to it across the lawn or field. Even a favourite toy will work. Of course, you can use a bird if you have one, but it is not at all necessary. If your pup is very young, let it watch and then let them track. Slowly and progressively, make it more difficult. Try not letting the dog watch you lay the track. Try hiding the dummy under a bush or in tall grass at the end of the drag. Make it longer. Put a turn or two in it. Do it all in tall cover. Work in a wet ditch or pond edge. Go back to easy ones occasionally.

Start with one that may only be 10 yards in length to maximize early success. In my experience, puppies quickly learn to actually scent your footsteps as well as the object dragged. No worries, they are still concentrating on ground scent.

When you start the pup, each time use the *same* word. This is not a command, *per se*; you are only trying to get the pup to associate doing the same thing when they hear the word, that is, slow down and use their nose. Be calm at the start of the exercise. Be certain to absolutely gush with praise and excitement when your buddy does well.

Don't worry about the retrieve. This exercise starts way before you have done any actual fetch training with commands. If parading is a huge problem, have your pup drag a ten-foot rope so that you can gently bring her or him to you for extra praise and delivery. You are only trying to not encourage bad habits at this formative stage, not teach and enforce a command. You can never start too early, and I find that my dogs have always enjoyed the game throughout their lives. The whole focus should be on encouraging your pup to use their nose to sniff ground scent. Sometimes all they want to do is search using air scent for the dummy (not track using ground scent), especially when starting the track. If you observe this, one of a few things is likely happening. It could be that they are bored; so quit for now, and try again later --later that day...that week...maybe longer. Use your own judgement. Or, maybe you have made the exercise too easy, and you need to make it more difficult. Another reason might be that you need to work on a slower, more deliberate start to the track. Help the pup keep their nose on the ground for a distance by walking with them. Show them what needs to be done. Remember, we cannot really teach the dog what ground scenting is all about. Obviously, they can naturally smell. Rather, you are encouraging them to slow down, use that wonderful nose for ground scent, and find a reward if they do. By the way, I have not noticed any issues with this exercise negatively affecting a dog's propensity to point or to use air scent when that is more appropriate.

There are a couple schools of thought on leaving treats to eat at the end of the track. Some say it is good positive reinforcement. Others think it introduces the idea of eating the bird at the end of a track. I have not used treats in that manner, but only because I think they are not all that necessary. In my experience, the act of finding the wing/dummy/bird is enough positive reinforcement, itself, —especially if accompanied by gushing praise and encouragement. However, I do provide treats and have a little party immediately at the end of the session.

I have no idea if this process will work for everyone and all dogs. Of course, there is nothing better than lots of hunting where the dog gets to track and is rewarded by a real bird! The combination of both activities has seemed to have given mine a leg up (pun intended). It is impossible to know if my little exercise has helped any, but both of my Fouseks have lost only five percent of the hundreds of birds shot over them. However, that rate seems pretty common in our breed based on conversations I have had with folks who keep such data journals for their dogs. And, both of my Fouseks scored 4s on all six of their tracking tests in both NAT and IHDT. Who knows, maybe I was simply fortunate to have received inherently good trackers.

This puppy exercise is not magical, but it might be something fun to try. I am sure there are many variations that have worked well for others. Certainly, it would be nice to see more dogs focus on the track, and see fewer of our dogs fall into search mode when tracking at their NAT and IHDT.
