On April 28-30, 2000 more than 100 humans and what seemed like close to that many dogs gathered in Baraboo, Wisconsin for the Heartland Chapter spring test. Overall, 21 dogs were tested, 10 in Natural Ability and 11 in intermediate. 14 prized and most of the others looked pretty good as well.

Among many fine performances, one in particular stood out as remarkable. Dick Bovard's **ARRIBA OF THE HIGH DESERT** received all 4's and a prize 1 in Natural Ability, but running in the same group was Dick's son Damon who has **ASHEN SHUGAR OF THE HIGH DESERT**. Ashen Shugar (Arriba's littermate) also got all 4's but was awarded a 4H in the search and a 4H in the track. This author is not sure but believes history may have been made when this dog received two 4H honors. Has it ever happened before??? Senior judge Vic Jaro and judges Jim Seibel and Dean Umphrey could not say enough good about this dog. It was a singular performance and one guaranteed to draw a crowded gallery come the Intermediate test.

There was a general discussion of various items pertaining to judging and during the last hour we hooked up (by conference call and loud speaker) with animal behaviorist Ed Bailey, back east in Ontario. Ed responded to questions from judges regarding our three tests: NAT, IHDT, and UFT. We were all pleased with the seminar.

It was great to visit with so many friends from the Midwest and Northeast: Dean Umphrey, Ken and Greg Hurtig, John Pitlo, Rick and Tina Molt, Phil and Dorothy Bennett, Jim and Arlene Seibel, Dave Seibel, and Bob Kasworm. Everyone enjoyed the pizza party Friday night in the motel hospitality room with such loud and lively conversation that other guests were complaining. Way to party down, gang!

Saturday and Sunday were spent testing 16 NAT and IHDT Dogs with 8 dogs performing up to a prize standard. Rusty Redfield (MT) and **ABEN OF THE AGASSIZ LOWLANDS** and Dave Checketts (NV) with **ANKA OF CHERRY POINT** showed great potential as future "Gun Dogs Supreme" by earning Prize I NAT Scores.

A littermate to **ANKA, ANGUS OF CHERRY POINT**, owned by Jeff Hogenson (WY) showed great potential also but had trouble with the NAT water work. Sometimes the age of the pup and living in a cold climate can present a challenge for water exposure prior to testing as it did for Jeff. As a judge/handler myself, my advice is to do whatever it takes to get those pups in the water and swimming so they can be comfortable in it by

Each day our test began with the traditional playing of the hunting horns and introductions from judges, handlers, and all participants of the days events.

Friday, Kevin Jester's dog, **BROOKE OF THE HIGH COUNTRY** ran the Utility Test; we saw wonderful searching and tracking, but no prize was given due to the lack of obedience. Then, we had four of the Iamonia litter to test in Natural Ability. Bob Frate's dog, **DUNCAN OF IAMONIA**, who had contracted Lymes Disease at a critical stage of development showed a lack of desire in the search so no prize was given. Hopefully, with lots of exposure to game she will overcome this and retest in NAT. Next on the days agenda were Peter Rosen's dog, **DORCHESTER OF IAMONIA**, and Peter Meyer's dog, **DAICEY OF IAMONIA**. **DORCHESTER** received a Prize I and **DAICEY** received all 4's, a perfect score and a Prize I.

Saturday we saw longtime club member Joe Kasmedo run his dog, **COOT OF IAMONIA**, in OHDT (five days over the two year old limit). This fine team earned a very nice Prize I. Then, it was back to the Iamonia "D" litter. Tim Schwager with his **DARBY OF IAMONIA**, earned a Prize II and Phil Lukish, with his dog **DEXTER OF IAMONIA**, a perfect score and Prize I.

Our test chairperson, Jane McKenna, scheduled a different fare from our previous Saturday evenings. We gathered at an old historic grange hall in Bowdoinham, ME., where the auxiliary fire department put on a barbecue. We feasted on grilled chicken, teriyaki chicken, cheeseburgers, garden salads, and lots of sweets for dessert. The evenings auction and fundraiser brought in approximately \$900. The last dog of the three day test was **DELIA OF IAMONIA**, owned and handled by Jim Sohns. The judges and gallery viewed an eleven month old dog turn in a stellar search, a true love of the water and an intense track of the live pheasant (changed gears like an old pro). All of this earned this fine young team a perfect score of 4's and a Prize I.

Once again, the Northwest Griffon Club hosted its spring test at the Mason's farm near Silver Creek, Washington. This is a wonderful site to test dogs and even though I have been there many times, I always look forward to returning. The weather cooperated with cool, slightly cloudy conditions, the scenery was beautiful and as always, it was good to see old friends and to meet some new ones.

This year we tested nine natural ability and three intermediate dogs over three full days. We had the opportunity to evaluate five pups from the **Cherry Point "A"** litter bred by Dick Bubb. There was a lot of consistency between these dogs and they all showed promise as fine hunting dogs. Unfortunately there was also a consistent weakness in their affinity for water. However, with the coming summer months and lots of exposure, all these dogs should be swimming eagerly before testing in IHDT. Our three intermediate dogs were also littermates from the **"A" of the Great Plains** bred by Larry Olson. Congratulations to Jeff Dillon and **AQUILA OF THE GREAT PLAINS** who received a prize III. We also test several non-club dogs with Gary Whiting and **COTTONWOOD BELLE** putting on a fine show. Belle received all 4's and a prize I. I always enjoy the opportunity to see some dogs from outside our breeding program and our chapter appreciates their support of our tests.

All in all it was a pretty typical weekend of testing except for one small item...the great bird escape. Late Friday afternoon as we returned to the parking area it was discovered that we had a problem. Somehow the door to the bird pen had been left unlatched and we now had birds scattered everywhere. There were birds walking around in the fields, birds on the barn, birds in the parking lot, birds on top of cars in the parking lot, birds everywhere! It was quite a sight what with judges, handlers, spectators and even a few dogs sneaking around trying to round up stray birds. We did manage to capture a few but we now had a fairly serious problem. How were we going to finish testing all the remaining dogs with the few birds we had left? Anyone who has ever been to a Griffon test knows that when you have a problem and need a "volunteer", you just look for someone who is waiting for a puppy. We didn't have far to look before Jim Halwachs volunteered. After driving four hours to come and see the test Jim agreed to drive six more hours to fetch us more birds. Started Saturday morning with the natural ability pups. First up, **CADENBERG YANKEE VON LOKI**, owned and handled by Mark Boyd, got us going with a lot of spunk, independence where more cooperation is desired, yet still overall Prize I. He was followed by **SIDE BY SIDE'S DAZZLER**, owned and handled by Silke Alberts, who gave an overall demonstration of what natural ability is all about, Prize I, perfect score. Her littermate, **SIDE BY SIDE'S DYNAMO MOLLY**, owned and handled by don Nelson, came next and also had a perfect score, Prize I. Lunch was hosted by Helen Webster, Sheryl Dallimore, and Donna Benseler, per usual featuring Helen's phantastic pheasant and lentil soup. Good food, lots of chatting, catching up to do, old times amongst old friends. But back to the field.....

We then shifted to hunting dog testing, intermediate and older. Dennis Carlson and his **CZECHERS OF IAMONIA** took us on a long search, multiple bird contacts, and finally a soft point, fine pheasant tracking, but some obedience problems. Off to the pond, not without trepidation, for duck work, but not to worry, all went well, shooting and retrieving, Prize II. Next came Sharon Jahn and her **WEIDENHUGEL BRIE VON SIMON**, no fooling around, took us hunting in all manner of cover and conditions, locked up tight on point, but then did little to help her hunting partner recover game. The five year old's disregard for who's supposed to be in charge continued at the pond; disobedience, no Prize.

On Saturday, we had two natural ability dogs and an older dog and finished up with duck chase exposure for

young dogs at the pond. We started in the morning with Jack Dallimore's new pup, **ABE OF CHERRY POINT** and all went smoothly until the gun shyness test. Despite distance and care in shooting, Abe was sensitive, though he recovered and went on to the pond to retrieve dummies. We next took Mark Boyd's 3 year old hunting partner, **SPILLER IDAHO SPUD**, who did his before-the-shot work very well; retrieving sufficient, Prize II. Last came Brie's daughter, **WEIDENHUGEL VIXEN VON EINER**, owned and handled by Sharon Jahn, who demonstrated much potential and is indeed her mother's daughter when it comes to cooperation and obedience, but at this stage, still a Prize I.

We had a few left over ducks, so the young dogs got a lot of action in the water. These ducks were real survivors, so everybody had a real workout, important learning experience and exposure.

At the awards dinner Saturday night, we were especially pleased to have the Baskins and Nadekers with us. Earlier in the day, Harold and I had reminisced about his old griffon, Luke (**LUKAS OF HUNTERS CREEK** - see Pedigree 153 in *THE BOOK*). So at dinner, I recalled an incident about Luke that occurred, good grief, many years ago. Harold and I were with Luke in Southern California for a NAVHDA test. We had reserved a double room at the motel, but when we got there after the test, we found not twin beds, but a double bed. ## NEWS FROM OFA

OFA is requiring permanent dog identification for all databases beginning January 1, 2001. This simply means your dog must have some form of permanent identification before they will examine hip or elbow x-rays. There are several choices you have, Dr Dave Birk describes our recommended method below.

On another note, July 1, 2000, OFA will institute owner choice pertaining to open or semi-closed database for hip, elbow, and patella databases. The open database will provide all information (normal & abnormal) in the public domain. The semi-closed database will provide only normal data in the public domain. We recommend you choose the open database.

## PERMANENT DOG IDENTIFICATION

Starting January of 2001, The Orthopedic Foundation of America (OFA) requires you to supply permanent identification for your dog before they will certify hips and/or elbows. Tattooing is one option, but I feel that Microchipping is a better choice. Most humane societies, shelters, and small animal veterinary clinics have "universal" scanners to ID pets that are brought in, if they have a microchip. Scanning is quick and painless and will read your dogs individual ID number, which is registered in a National Data Bank.

Microchipping is a simple procedure that can be done with or without anesthesia. Most hip x-rays will require sedation or tranquilization, and if done then, your dog won't realize he/she has been implanted.

In our practice, we use the AVID Microchip and although cost will vary throughout the US, we charge about \$45.00, which includes the registration into the national database. The chip, about the size of a grain of rice, is placed along the back, between the shoulder blades, into the deep fascia, using sterile technique. They do not fall out, or move, and you don't have to search all over for possible tattoo sites, i.e. inside the thigh, lip, ear, etc. The process works by the scanner sending a message to the microchip and it sends back the unique ID number. You do not have to touch the dog to get a reading. Ask your veterinarians' opinion, but in our practice, our clients are very pleased with the microchip. ## HOW IMPORTANT IS EXPOSURE??

From birth through the first year, there is nothing more important for a young dog than exposure. It all begins with the breeder. They start these pups with exposure to children, lots of different people, trips in a vehicle, and other situations that a dog might encounter in life. One day it might be to an open field, the next day to a wooded area and maybe a creek bottom. The important point in all of this is getting the pup OUT THERE.

This past spring, Jim Seibel, Greg Hurtig, myself and the rest of Sundays gathering at the Maine test witnessed a wonderful example of exposure.

I was walking along with handler Jim Sohns and was admiring the dog's search and her sound conformation. Knowing that this pup was only four months old at the beginning of the last hunting season, I was curious as to what this young team had encountered last fall. When I asked Jim about how much hunting he got in he told me that at the beginning of the season he was still working on breaking in the pup to the gun. When he knew the dog was ready, Jim would be ready. Although they encountered some wary grouse (flushed way out in front of the dog) and the handler had bumped some woodcock (no fault of the dog) Jim did not shoot any non-pointed birds.

The season ended with no birds in the bag, but the bag was FULL. Full of Exposure. There were all of those days afield, hunting, scenting where game was, learning where game might be found, putting this all in the memory bank of the young dog. Jim and DELIA OF IAMONIA continued to take these daily jaunts into the woods and fields after the season ended, further aiding this young dog to reach her full potential.

At the spring test, one would have guessed that this dog had many, many birds shot over her the way she searched, changed gears during her tracking, and the way she entered the water. What got her to this point was just plain EXPOSURE!!

The great dogs that we see at our tests and in the field during the hunting season do not just happen. The potential for this greatness lies within these dogs, but it must be developed. Developed from puppyhood to adulthood by the most important concept of all, EXPOSURE.

*Editors note:* I couldn't agree more with Rick. Perhaps the best analogy I could draw is the following. How often haven't we heard "that child has an aptitude for music or he/she is very athletic". What follows are years and years of practice on a musical instrument or hours and hours of practice on the gym floor to develop those skills to the fullest. Without all that practice, the aptitude withers and never reaches its full potential. This concept is the same as with puppies, who were born with aptitudes to find game. They need hours and hours (yes, even years) of "practice" i.e. EXPOSURE, to fully develop the aptitudes they were born with. So, EXPOSE, EXPOSE, EXPOSE!!
