First report of the pheasant hatch is that it was somewhat below average, with wet conditions throughout the state during the nesting season. Spring hunting tests were conducted by the KDK in California, Northwest, Heartland, and Northeast Chapters. Write-ups for each are included in this issue. As usual, this issue contains the results of the spring field tests, with all the dog scores and pedigrees. This was a special spring for us because we were fortunate to have Dr. Jaromir Dostal with us. He is the Breed Warden for the Czech Fousek Club. Vivian and I met Dr. Dostal at O'Hare International in Chicago and after a short stay at our home, we proceeded on the 2-day drive to Jerome, ID and the spring Judges Seminar. Ken and Karen Hurtig, Greg Hurtig, Judy Coil (club secretary), Dr. Dostal and myself, all traveling in Ken's large van. It was a perfect time to show Dr. Dostal all the various cover and terrain that our dogs must hunt, from pheasants and quail in the corn and CRP of the Midwest, to sharpshooters and pheasants in the grasslands of western Nebraska and Colorado, to chucker and quail in the foothills of much more rigorous cover in Wyoming, Idaho and states further west. Dr. Dostal led the seminar and covered the history of the Fousek, explained some of the data they keep/collect and how breeding decisions are made. It was a tired crew that headed back to the Midwest, but there was much talking about dogs, comparing of our testing program with that in the Czech Republic, quizzing Dr. Dostal about various things he had seen and learned at the Idaho test, and in return, answering his many questions. It was truly a great Judges Seminar for all of us! I hope to see many of you at the tests this fall.

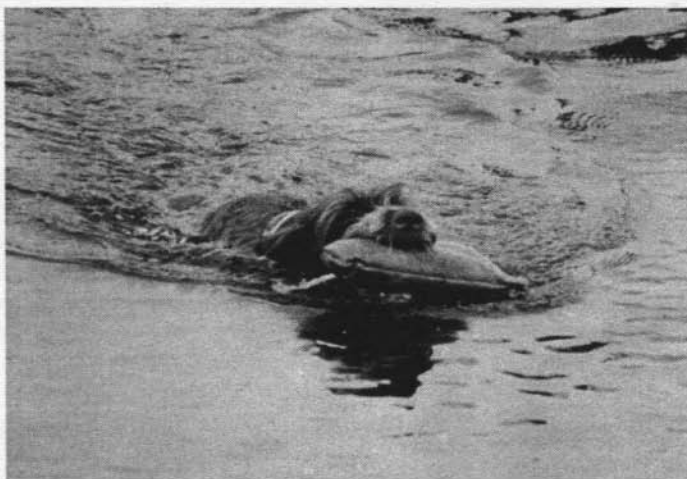

Thanks also go to Lynn & Stan Sukup for organizing some meals and lodging, Ken and Karen Hurtig for all they do as hosts, Dean Umphrey, who came to the rescue in locating /delivering birds, Brenda and Sid 'Siefken' for fund raising, and to all the various doers who contribute to pull this event off.

95 plus griffoneirs attended the traditional Saturday night dinner at the Farm Kitchen. Feeling abandoned in the parking lot, a chorus of dogs serenaded the diners throughout the meal. Raffles, door prizes, silent auctions, good food, and super camaraderie made for a great evening.. The title of youngest new Heartland member was a virtual tie between the Seifkin and Vannoy babies who were born within days of each other last October. Once again the Masons allowed us to use their beautiful property near Silver Creek, Washington as our testing site this year. This is a great site with good cover to test dogs, excellent water and several ideal viewing spots for the gallery to watch the action. The weather cooperated throughout the weekend with cool, cloudy conditions and only an occasional shower on Saturday.

We only had six dogs to test this weekend, which made for a nice relaxing test for everyone, except the handlers of course. They don't ever seem to relax until after the scores are read. I know because this weekend I was one of the nervous handlers. Vic Jaro came over from Idaho to help with the judging. He has such a calm, easy manner that really helps to put the nervous handlers at ease. Dennis Carlson, Victor Woodward and I rounded out the judging team.

On Saturday we tested three intermediate dogs. At three years old, Don York's **CHESNA OF IAMONIA** was judged as an older hunting dog. **CHESNA** was eager in the field but tentative around the water and therefore wasn't able to prize. Carson Kendall ran **ADDEE OF CHERRY POINT** and despite good work in the field was unable to prize because she also had problems with the water work. After a delicious lunch, provided by the Heubleins, we devoted the afternoon to testing **AJAX OF CHERRY POINT**, owned by Dick Bubb. **AJAX** was tested last fall and some temperament issues surfaced under the pressure of the test. Dick has patiently brought this dog along and they improved on many of their previous scores as well as have become an effective hunting team. Sunday was spent with the natural ability dogs and it was a great day for everyone. Jim Gannaway ran **B-RUN GRAYS OF HIGH DESERT**, Michel Mormmier ran **BART OF HIGH DESERT** and I ran **GRACIE OF**



**AUGER FALLS.** Michel is an enthusiastic handler, very positive and always praising his dog. The result showed in how eager and happy **BART** was, especially with retrieving. At day's end we all had reason to celebrate when all three dogs received all 4's and Prize I.

**NORTHEAST SPRING TEST 2001***by Rick Molt*

The newly acquired grounds, Green Point Wildlife Management Area was home to this years 2001 spring test in Maine. Starting on Friday, May 18th, senior judge Rick Molt, along with judges Gary Pool, Ken Hurtig and apprentice judges, Phil Bennett, Kevin Jester, and Eric Anderson tested two dogs. The dogs were littermates from the 'D' of Iamonia litter, **DORCHESTER OF IAMONIA** and **DARBY OF IAMONIA** owned and handled by Peter Rosen and Tim Schwager, respectively. Both received very strong prize II's in their IHDT's.

Saturday was a busy day with four dogs to test and puppies to expose. Two littermates, **MERRYMEETING'S BEAU GESTE** owned by Mike Cregan and **MERRYMEETING'S BRANDY** owned by Mark Dougherty were tested in NAT. BEAU, a strong dog earned a perfect 28 points and a prize I while BRANDY earned a prize III. John Sladika's dog, **DANUSHKA OF IAMONIA**, has been undergoing treatment for lyme's disease. From the way she searched in the field to her tracking, one would have never guessed and she earned a very nice prize II. Bob Carlson ran his dog **BUCKEYE OF TRUMAN'S PRIDE** in OHDT. He is a bold and strong male and did everything quite well except for his retrieving and therefore received no prize.

After we were done testing the dogs we had a chance to play with three 4+ month old pups. We let the pups chase and catch some chukars. Some, more intense than others, but that's the way pups are. They all come on at different times. The breeders, Mark and Joann Canfield, were on hand to see some of their wonderful looking pups. Long time club member, John Diller with his pup **AVERY OF VALLEY HOUSE**, and new members Nate Newman and Shannon McDermott with their pups **ARLO OF VALLEY HOUSE** and **AUDREY OF VALLEY HOUSE**, respectively, all had a chance to expose their young pups to older dogs, game and the events that go on during the test.

Along with new test grounds, we had a change in Saturday Nights dinner location. Jane McKenna, our co-chair, found a trap and skeet range with clubhouse known as the Richmond Sportsman's Club. Club members put on a barbecue of chicken, hot dogs, hamburgers, salads, cakes and cookies. It was a very relaxed atmosphere and we just took over like it was our very own place.
