Northeast Fall Test-2001 By: Rick Molt

The annual Northeast Hunting Test was held on September 22nd & 23rd in Bristol, Maine. Once again we were able to use the grounds of Gerald Foster's old farm and the wonderful beaver ponds for the water work at Bill Clark's farm.

The weather on Saturday was misty in the A.M. and cloudy in the P.M. with temperatures in the 60's making for great condi-

tions to test the dogs. We tested two IHDT's both from the Merrymeeting kennel. MERRYMEETING'S BEAU GESTE owned and handled by Mike Cregan went on to a prize III. Beau is a very strong and bold dog with lots of potential. Littermate MERRYMEEING'S BRANDY owned and handled by Mark Dougherty earned a prize I. Mark and BRANDY have come a long way since NAT and are on track to become a great hunting team.

Due to the lack of judges we were unable to test three UFT dogs, and at the last moment I asked two handlers if they would test their 8month-old pups. They were Nate Newman with ARLO OF VAL-

LEY HOUSE and John Diller with AVERY OF VALLEY HOUSE. ARLO showed amazing potential with perfect scores and a prize 1. The results are definitely due to the correct exposure and the fine breeding of this dog, exemplified by the young age of 8 months.

Saturday evening we had a "Downeast" lobster-clam bake with corn, potatoes, onions, hard boiled eggs, lots of lobster and clams, melted butter, all steamed over rock weed. We were treated to this culinary delight by lobster fisherman Isaac Molt, his sister Hillary and her friend Jesse Bulmer. After consuming bountiful portions of food we read the scores and held an impromptu fund raiser. It seems as though a lot of the

Jane McKenna and ARUNDEL (Del) did a pheasant track, and at the end of the track did some pointing. ADMIRAL DOZER owned by Rick Molt did a pheasant track and delivered the bird to hand.

Whenever you have a test and all dogs prize and the outlook of new pups is so high, its a wonderful weekend. Thanks go out to all the handlers, gallery of onlookers, bird handlers, workers and the apprentice judges Phil Bennett, Kevin Jester, Erik Anderson, and Peter Meyer


